Issue: Jefferson County Human Services' Community Assistance Division seeks approval to submit to the Colorado Department of Human Services (CDHS), and accept if awarded, \$92,094.45 in funds to support activities related to the administration of the Supplemental Nutrition Assistance Program (SNAP) for Federal Fiscal Year 2022 and 2023.

Background: Jefferson County Human Services administers the Colorado SNAP program for county residents. The American Rescue Plan Act of 2021 (ARPA) provided limited funding for specific activities for the administration of SNAP during the Public Health Emergency (PHE). As we prepare for the end of the PHE, CDHS has reallocated funds for County use.

Discussion: The record number of Coloradans enrolling in SNAP continues to increase workload for Human Services. In response to the increased workload, CDHS has designated federal funds to be used by counties to address this issue. Human Services is requesting approval to apply for \$92,094.45 of these funds, which Human Services would use in three ways. First, we intend to improve the customer experience when visiting our lobby. To decrease customer wait, three self-serve computers and a self-check-in kiosk, would be installed. Additionally, because many customers struggle with the use of technology and prefer waiting in line to speak with someone, we would hire temporary staff to greet and assist customers with self-help options.

Secondly, funding would be used to revise our SNAP webpage, instructions, and guidance to ensure program information is easy to find, clear and concise. Finally, we would provide one-time retention payments to eligibility staff who continue to work increased caseloads.

Issue: Due to delays in the Workday Time and Absence implementation, there is a need to issue a change order to Alight to complete the work. This change order extends the current Purchase Order over the \$500k limit.

Background: In Q2 2021, the Workday Time and Absence project was started with an anticipated go live of Q1 2022. The project was on track as the team started the end-to-end testing phase in January 2022. During the month of January, several changes occurred causing the project to be delayed. Some of the influences creating a delay included staff shortages, staff turnover, and opportunities to better accommodate and manage legally mandated leave programs.

At this time, the Workday Time and Absence project is scheduled for a Q4 2022 go-live and will provide a fully integrated system for time tracking, time off and absence requests and eliminate manual processes that exist with our current software and business processes.
