## **Special Meeting Notice Regarding the Sunset Park Basketball Courts**

The Bowles Metropolitan District Board (BMD) would like to invite you to a special meeting on August 25th at 4:30 PM at the Grant Ranch Village Center to discuss the current usage of the basketball courts and the potential temporary alterations to reduce rules violations.

The BMD Board has decided to call a special meeting to gather community input on the suggested removal of the some or all basketball hoops in Sunset Park. The Board would like to hear from the community before making any decision to alter a community amenity.

### **The Districts rules for the park are as follows:**

- House of operation: 6am to 9pm.
- All pets must be on a leash and pet owners must pick up after their pets.
- After hours, parking at the BMD parks is prohibited and all vehicles found after hours will be towed at the owners expense.
- Motorized vehicle use inside the park is prohibited.
- Offering/advertising items for sale of any kind at BMD parks is prohibited.
- No amplified noise or music. Jefferson county noise ordinances apply. [Click here for Jefferson County Ordinance.](#)
- All trash/litter must be deposited in a trash receptacles.
- All weapons/fireworks are prohibited.
- Team sports/activities on BMD grounds must have prior BMD approval.

### **Additional FAQ's**

- The BMD Board will not be entertaining a permanent removal of the basketball courts. The intention of the meeting is to decide the best solution to address community concerns about the basketball courts, including temporary removal of the Districts hoops.
- The District has received many complaints about organized teams using the court in violation of the Districts policies. Other complaints include aggressive and inappropriate behavior, trash, music being played in violation of the Districts polices, and late night usage.
- The Bowles Metro District (BMD) will host both a virtual and in person meeting. However, indoor limitations at the Grant Ranch Village Center do apply and will be enforced. We highly encourage residents to participate online if possible. If there are more residents in attendance than the Village Center's indoor capacity can hold due to Jefferson County Covid-19 guidelines, the Board will allow residents looking to speak in to the meeting room until capacity is reach and then one person at a time after that. We would encourage residents who have already spoken to exit the meeting room to allow others that have joined the opportunity to come inside and speak.
