- A legal description of the license agreement area and an exhibit showing the area, prepared by a licensed surveyor
- Final construction or landscape plans (if required) showing proposed improvements, such as fences, signs, grading changes, sidewalk, median, etc, with these standard items and notes:
 - North arrow, graphic scale, and text that will be legible when the drawing is reduced to 8.5"x11"
 - Note: "Proposed tree and fence locations shall be field staked and reviewed by Jefferson County Road and Bridge prior to planting."
- Note: "Call 811 Utility Notification Center of Colorado 2 business days before you dig, grade or excavate for the marking of underground member utilities."
- Proof of ownership of the adjacent private property
- If the applicant is a HOA or corporation, the name and contact information for the officer(s) who will sign the agreement on behalf of the HOA or corporation
- Proof of the officers' authorization to sign on behalf of the HOA or corporation, typically the Articles of Organization and meeting minutes covering the election of officers
