MODIFICATION OF PREMISES-CHECKLIST

THIS PROCESS CAN TAKE APPROXIMATELY 2 MONTHS

Modification of Premises (REG. 47-106): Request to change, alter or modify premises or addition of premises to a liquor license.

- Any increase or decrease in total size or capacity of licensed premises.
- Sealing off, creation or relocation of ingress/egress points from public thoroughfares, streets, parking lots, etc.
- Relocation, additions/deletions of any bar/coolers/etc.
- A change that materially alters use of the premises from the initial application.

Please submit THREE (3) copies of application and supplemental documents

Application Checklist:

State Application (DR844) with Page 1 and Section 9 completed.

School Affidavit

Letter of permission from the landlord/owner authorizing modification and stating that the current lease is still in effect

Diagram (8.5X11) of the currently liquor licensed premises (i.e., the “before” liquor premises)

Diagram (w/ dimensions) of the proposed liquor premises (i.e., the “after” liquor premises)

A geographic map (Google Maps or similar) that includes location and surrounding area

Detailed letter from the applicant describing the proposed change(s)

If adding/expanding a patio/deck, list the height of the fence/railing, the composition of materials used and how you will control alcohol (i.e. to ensure alcohol does not leave the premises, underage drinking and over service)

Fee is payable to the Colorado Dept. of Revenue: \$150.00 (\$300 total if modifying for specific dates and modifying back)

At the time of application, we will provide you with a SIGN that must be posted for 10 days notifying the public of the proposed changes. If protests are received, you will be notified to attend the next Jefferson County Liquor Licensing Authority Hearing.
