I understand, acknowledge and agree that intentional violations of the following violations may result in immediate revocation of my access control badge:
 - 1. Loaning the airport access control badge to anyone under any circumstance.
 - 2. Allowing unauthorized individuals or vehicles into the non-movement area.
 - 3. Leaving gates open that could result in unauthorized individuals or vehicles entering the non-movement area.
 - 4. By-passing the Access Control system.
 - 5. Causing or allowing access to anyone that results in a Vehicle/Pedestrian Deviation (VPD) and/or Runway/Taxiway incursion.

- I agree to return the badge issued by the Rocky Mountain Metro Airport when use of the badge is no longer required for the purpose for which it was issued or the use is no longer permitted by Airport Management; or when I am no longer employed with the above company; when the badge is lost or stolen and later recovered; when the badge has expired; or if my driver's license status changes.
- I agree to pay all fees, penalties or charges set forth by Rocky Mountain Metro Airport for the badge and permits issued to me when these items are no longer required for the purpose for which they were issued; or their use is no longer permitted by the Airport Management; or when I am no longer employed with the above company; or when any of these items are lost or stolen; or have expired and have not been returned to Airport Management.
- As a condition of being issued a badge and/or permit, I hereby agree to comply with any policies, provisions, or procedures which the FAA and/or Airport Management have promulgated or promulgate in the future and deem necessary to ensure the security and / or safety of operations at Rocky Mountain Metro Airport.
